
Total Population Crisp County



Population Change: 1930-2000






Population Change: 2000-2009




Highest Level of Educational Attainment: 2000









Persons Living Below the Poverty Level 2008 Model-Based Estimates




Weighted average poverty threshold for a family household of 4 persons in 2008 = \$22,025



Selected Employment Comparisons by Industry: 2008






Retail Sales Analysis: 2008 Crisp Co. Total Retail Sales = \$334,994,000
